Deduct \$0.020/bbl per full degree below 40.0 degrees API gravity.

#### Texas

West Texas Sour                      Deduct \$0.03/bbl per 1/10 degree above 44.9 degrees API gravity.  
Deduct \$0.015/bbl per 1/10 degree below 34.0 degrees API gravity.

West Texas Intermediate              Deduct \$0.008/bbl per 1/10 degree above 44.9 degrees API gravity.  
Deduct \$0.008/bbl per full degree below 40.0 degrees API gravity.

Upper Texas Gulf Coast              Deduct \$0.03/bbl per 1/10 degree above 44.9 degrees API gravity.  
Deduct \$0.020/bbl per full degree below 40.0 degrees API gravity.

Texas Gulf Coast Light              Deduct \$0.03/bbl per 1/10 degree above 44.9 degrees API gravity.  
Deduct \$0.020/bbl per full degree below 40.0 degrees API gravity.

South Texas Sour                      Deduct \$0.03/bbl per 1/10 degree above 44.9 degrees API gravity.
